## A. Call to Order

## D. Announcements

1. Bill Gallagher has sent out the link and assignments for Bruce Dallas on 4/7/18. Coach P & Greyhound assignments are close to being finalized. Women's jumps official is still needed for the Greyhound Meet at Moravian. MAC assignments are very close to completion also. Laser measurement will be used for selective field events at the MAC. The MAC is also being expanded to 3 days. Last chance to sign up for District III Meet.

# E. Presentation on Officiating: Shot Put (PIAA Suggested Techniques for Track & Field Officiating p.37-41; NFHS p.43-48; Case Book 84-85)

- Know the Rule Book and applications.
- No warmups prior to official's arrival or coach present. Event is also closed at conclusion.
- Identify any conflicts of contestants in other events.
- No athletes should be in the sector during warmups or competition.
- Check implements for defects. Shots may have been weighed and certified legal by a weighmaster.
- Know your calls: Up, On Deck, On Hold.
- No tape on hand or fingers. Chalk is permissible.
- A good technique to insure safety is to block the circle until the sector is clear, make the calls, and then exit for the next competitor to initiate a throw.
- Meet management or games committee determines the number of trial throws and finals, including the number of advancers to the finals.
- Minimum standards and procedure for recording substandard throws is determined by meet management.
- Throws must be COMPLETELY in the sector. Measurement is made from closest impact point to the inner edge of the toe board.

• Competitor must start from a stationary position. Stay in circle until implement lands and exit from back half of the circle. No contact can be made with the circle outside the band or line and the top of the toe board.
