G. Presentation #4: Brad Cashman & Cherie Ramsey
Brad opened tonight's lesson and then turned it over to Mark Morris, one of our newer
Chapter officials who has extensive experience in the pole vault through coaching and
instructing vaulters in technique and form. Mark conducted the lesson by reviewing the
rules and providing examples from personal experience.

A Q&A session led into discussion about several concerns related to the pole vault event that various officials have encountered during officiating meets. This led back to the mention by Jim Ellingsworth of the priority of officials making certain that the Pole Vault Verification form is filled out and reviewed prior to the start of the event. This again brought up the issue of the need for 2 PIAA officials being present at meets. Jim was asked if he could have that issue, requiring all schools to hire both a Starter/Referee and a Head Field Judge for meets, put in the agenda of the PIAA for consideration at the annual meeting. Jim said he would do so.
