Call to Order: President Lerew called Chapter Meeting #4 to order at 6:00PM.

Treasurer's Report: Skip gave the amount of \$3,258.93 as the current treasury balance.

Assignor/Arbiter Updates: Prior to giving his report this evening, Larry went into detail about an issue with the pole vault venue at Middletown H. S. this past and the ensuing difficulties in determining the correct scoring procedure. There were a number of other factors involved with the event itself which further complicated the issue. This matter had a direct tie in to tonight's officiating lesson and generated a lively discussion of the matter with a number of members contributing valuable thoughts and insights. The issue remains in need of additional attention and clarification which is likely to be followed up at next weeks in person meeting, as Larry may be again dealing with a similar situation since he will have another varsity meet at Middletown this coming week.

Larry presented his usual report then and noted that weather problems in the past week caused major problems with re-scheduling, but most meets appeared to be back on track on a variety of days in addition to the usual Tuesday/Wednesday/Thursday schedule. Larry again reminded officials to block

May 11th in Arbiter only if they DO NOT plan to take an assignment at the Mid-Penn Championship at Chambersburg on that date. We may have to go outside of our Chapter to staff the meet.

President Lerew quickly ran through the assignments for other upcoming invitationals with the various assignors and all appear to be moving ahead in a positive manner.
